RESOLUTION NO. SP. 7036, S-2017

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO SIGN THE DEED OF DONATIONS IN FAVOR OF THE SANGGUNIANG BARANGAYS OF BARANGAY BAGBAG, BARANGAY FAIRVIEW, BARANGAY GULOD AND BARANGAY SAN BARTOLOME, DISTRICT V, QUEZON CITY, FOR THE DONATION OF ONE (1) UNIT OF MITSUBISHI L300 VAN TO EACH BARANGAY AND AUTHORIZING THE TRANSFER OF OWNERSHIP OF THE SAID VEHICLES TO THE RECIPIENTS WITHOUT COST.

WHEREAS, under Section 2, Article I of Republic Act No. 9184, also known as the Government Procurement Reform Act, it is the policy of the State to promote the ideals of good governance in all its branches, departments, agencies, subdivisions and instrumentalities including government-owned and/or controlled corporations and local government units;

WHEREAS, the Quezon City Government, through the Office of Councilor Andres Jose G. Yllana, Jr. of District 5 has procured four (4) units of Mitsubishi L300 Vans;

WHEREAS, the said vehicles shall be for the use of the four of the largest barangays in District 5, namely: Barangay San Bartolome having a land area of 240.62 hectares and a population of 46,437, Barangay Gulod with a land area of 98.6073 hectares, Barangay Bagbag with a land area of 200 plus hectares and population of 42,260 and Barangay Fairview with a land area of 350 hectares and a population of 70,000;

WHEREAS, the Sangguniang Barangay of Barangays Bagbag, Fairview, Gulod and San Bartolome will be greatly benefitted from being the proper recipients of a donation in aid of legislation of these city-owned vehicles;

WHEREAS, the City Mayor is authorized, pursuant to Section 445 of the Local Government Code of 1991, to represent his City in all the City transactions and to sign documents on the city's behalf upon the authority of the Sangguniang Panlungsod.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to sign the Deed of Donations in favor of the Sangguniang Barangays of Barangay Bagbag, Barangay Fairview, Barangays Gulod and Barangay San Bartomome, all of District V, Quezon City, for the Donation of one (1) unit of Mitsubishi L300 Van to each Barangay and authorizing the transfer of ownership over the said vehicles to the recipients without cost.

RESOLVED, FURTHER, that ownership of the said vehicles shall be transferred to the recipients through a Deed of Donation to be signed by the City Mayor, Honorable Herbert M. Bautista, the Office of Andres Jose G. Yllana, Jr. as the main proponent and the City General Services Department (CGSD) represented by Mr. Rolando P. Montiel.
