A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO DISPOSE OF AND TRANSFER THE OWNERSHIP OF A MOTORIZED VEHICLE WITH LICENSE PLATE NO. SJN 744, REGISTERED UNDER THE NAME OF THE QUEZON CITY GOVERNMENT, BY WAY OF DEED OF ABSOLUTE SALE IN FAVOR OF MA. TERESA M. MARIANO, HEAD, SOCIAL SERVICES DEVELOPMENT DEPARTMENT, AT A REASONABLE PRICE TO BE DETERMINED BY THE APPRAISAL COMMITTEE AND SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.


NOW, THEREFORE,


