RESOLUTION NO. SP. 7038, S-2017

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH MAYOR HERBERT M BAUTISTA, TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (Php1,500,000.00), TO THE MUNICIPALITY OF SANTA CRUZ, MARINDUQUE, FOR THE REHABILITATION OF ITS PUBLIC MARKET, DESTROYED BY TYPHOON "NINA", SUBJECT TO EXISTING ACCOUNTING AND AUDITING LAWS, RULES AND REGULATION.

WHEREAS, the City Government is empowered under Section 447 (1), (IV) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, "To adopt measures to protect the inhabitants of the municipality from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance for the victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events";

WHEREAS, on 26 December 2016, Typhoon "NINA" struck the Philippines, leaving devastation and extensive damage to the economy, home and infrastructure, communication and vital government facilities, buildings, residential areas and agricultural sector;

WHEREAS, Typhoon "NINA" was a destructive natural calamity which took several lives, and destroyed millions worth of agricultural products and properties of our countrymen especially in the provinces of

Bulacan, Pampanga, Bataan, Zambales, Marinduque, Oriental Mindoro, Occidental Mindoro, and Northern Samar;

WHEREAS, the Municipality of Santa Cruz, Marinduque through its Municipal Mayor Marisa Red Martinez is seeking financial assistance from the Quezon City Government for the rehabilitation of its Public Market located at Santa Cruz, Marinduque;

WHEREAS, the Quezon City Government expressed sympathy for the victims of typhoon "NINA", most specifically for Municipality of Santa Cruz, Marinduque;

WHEREAS, the Quezon City Government, through City Mayor, Honorable Herbert M. Bautista, is donating the amount of One Million Five Hundred Thousand Pesos (PHP1,500,000.00), as financial assistance specifically for the purpose of the rehabilitation of its Public Market located at Santa Cruz, Marinduque.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Quezon City Government, through Mayor Herbert M. Bautista, to grant financial assistance in the amount of One Million Five Hundred Thousand Pesos (PHP1,500,000.00), to the Municipality of Santa Cruz, Marinduque, for the rehabilitation of its Public Market, destroyed by typhoon "Nina", subject to existing accounting and auditing Laws, Rules and Regulations.
