RESOLUTION NO. SP. 7040 , S-2017

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH MAYOR HERBERT M. BAUTISTA, TO GRANT FINANCIAL ASSISTANCE TO "THE REGIONAL PEACE AND ORDER COUNCIL", IN THE AMOUNT OF TEN MILLION PESOS (PHP10,000,000.00), SUBJECT TO EXISTING ACCOUNTING AND AUDITING LAWS, RULES AND REGULATIONS.

WHEREAS, Executive Order No.773, "FURTHER REORGANIZING THE PEACE AND ORDER COUNCIL" specifically provides:

"(b) Regional Peace and Order Council (RPOC) shall be composed of the region's Provincial Governors, the Mayors of the Highly Urbanized Cities, the President of the Leagues of Municipalities, the regional

counterparties of the departments, offices and agencies enumerated in paragraph (a) above wherever applicable, with the Chairman and Vice-Chairman to be appointed by the SILG with the approval of the President of the Philippines from among the members of the Council. In addition, there shall be one representative of the Mayors of Component Cities to be chosen from among themselves. The chairman of the RPOC shall appoint the three (3) representatives of the private sector, upon consultation with the members of the Council and upon acquiring appropriate security clearances. The regional counterpart of the CSAFP shall be the Commander of the Infantry Division. Departments, offices and agencies with no regional and/or field offices shall not sit in the RPOC."

WHEREAS, President Rodrigo Duterte appointed Mayor Herbert M. Bautista as Chairperson of the Regional Peace and Order Council in the National Capital Region (RPOC-NCR);

WHEREAS, Mayor Herbert M. Bautista as Chairperson of the RPOC-NCR vowed to maximize its resources and closely coordinate with the concerned sectors in order to effectively address Metro Manila's concerns in terms of national security and peace and order;

WHEREAS, Honorable Herbert M. Bautista in his capacity as Mayor, acceded to assist the Regional Peace and Order Council – National Capital Region (RPOC-NCR), in every reasonable means by donating the amount Ten Million Pesos (Php10,000,000.00) to carry out its mandate and its activities;

WHEREAS, the donation of the said amount is necessary to promote and provide support to the Regional Peace and Order Council in the National Capital Region (RPOC-NCR).to attain its mandate and objectives.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Quezon City Government through Mayor Herbert M. Bautista, to grant financial assistance to "The Regional Peace and Order Council-National Capital Region (RPOC-NCR)", in the amount of Ten Million Pesos (PHP10,000,000,00), subject to existing accounting and auditing laws, rules and regulations.
