
WHEREAS, the donation of five (5) units of computer sets aim to improve the delivery of administrative services in District 5, Quezon City;

WHEREAS, for the effective turn-over of the ownership of the said computer sets to the recipient barangay, the City as Donor shall assume all fees and costs of the Donation.


NOW, THEREFORE,
