RESOLUTION NO. SP. 7065, S-2017

A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT (MOA) ENTERED INTO AND SIGNED BY AND BETWEEN THE QUEZON CITY GOVERNMENT (QCG) REPRESENTED BY CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, AND THE PROVINCIAL GOVERNMENT OF ILOCOS NORTE (INPG), REPRESENTED BY GOVERNOR IMEE R. MARCOS, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, Republic Act No. 7394, also known as the Consumer Act of the Philippines, declares the state policy "to protect the interest of the consumer, promote the general welfare, establish standards of conduct for business and industry, and thus, shall implement measures to provide protection against deceptive, unfair and unconscionable sales act and practices;

WHEREAS, Section 455 (b) (1) (vi) of Republic Act No. 7160, states that "the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance"; y

WHEREAS, under Republic Act No. 6977, as amended by Republic Act No. 8289, Section 5, (c) Goordination of Government Efforts. Government efforts shall be coordinated to achieve coherence in objectives. All appropriate offices, particularly those under the Department of Trade and Industry, Finance, Budget Management, Agriculture, Agrarian Reform, Environment and Natural Resources, Laboranđ Employment, *Transportation* Works Communication, Public and Highways, Science Technology, and Local Government as well as the National Economic Development Authority and the Central Bank of the Philippines, through their national, regional, and provincial offices, shall, to the best of their effort and in coordination with local government units, provide the necessary support and assistance to small and medium enterprises:

WHEREAS, the Quezon City Government (QCG), through Mayor Herbert M. Bautista and the Provincial Government of Ilocos Norte (INPG), through Governor Imee R. Marcos, as parties to the Memorandum of Agreement agreed to provide economic opportunities for participating local farmers and Micro Small and Medium Enterprises (MSME) owners/producers to showcase and market their products through a Producer 2 Consumer Program (P2C) in Quezon City;

WHEREAS, in view thereof, there is a need to ratify the Memorandum of Agreement signed by the parties and to authorize the City Mayor, Honorable Herbert M. Bautista, in his capacity as the Chief Executive of Quezon City;

WHEREAS, the City Council hereby authorizes the City Mayor, Honorable Herbert M. Bautista, for and behalf of the Quezon City Government, to enter into and sign a Memorandum of Agreement.

NOW, THEREFORE.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to ratify, as it does hereby ratify the Memorandum of Agreement (MOA) entered into and signed by the Quezon City Government (QCG) represented by City Mayor, Honorable Herbert M. Bautista, and the Provincial Government of Ilocos Norte (INPG) represented by Governor Imee R. Marcos, subject to existing Laws, Rules and Regulations.
