RESOLUTION NO. SP	700.	, S-2017

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO SIGN THE DEED OF DONATION IN FAVOR OF QUALIFIED SUBDIVISIONS LOCATED IN BARANGAY BATASAN HILLS, BARANGAY HOLY SPIRIT, BARANGAY BAGONG SILANGAN, BARANGAY COMMONWEALTH, AND BARANGAY PAYATAS, DISTRICT 2, QUEZON CITY FOR THE DONATION OF EIGHTY THREE (83) UNITS OF BASKETBALL BOARD AND AUTHORIZING THE TRANSFER OF OWNERSHIP TO SAID INSTITUTIONS WITHOUT COST.

WHEREAS, the City Government of Quezon City, shall donate eighty three (83) units of basketball board to qualified beneficiaries (subdivisions) in Barangay Batasan Hills, Barangay Bagong Silangan, Barangay Holy Spirit, Barangay Commonwealth and Barangay Payatas;

WHEREAS, the said donation shall be accompanied by a Deed of Donation containing specifications of each basketball board subject of donation and the condition/s imposed on the transfer;

WHEREAS, the eighty three (83) units of basketball board to be donated to qualified subdivisions in Barangay Batasan Hills, Barangay Holy Spirit, Barangay Bagong Silangan, Barangay Commonwealth and Barangay Payatas, this City, for the prompt delivery of public service within the subdivision subject of donation;

WHEREAS, said donation is understood to be for community recreational purposes only and the use shall be exclusive only within the subdivision subject of donation and must not be used for personal, business, financial or profitable undertaking;

WHEREAS, it is provided under Section 36 of Republic Act No. 7160, also known as the Local Government Code of 1991, that "A local government unit may, through its local chief executive and with the concurrence of the Sanggunian concerned, provide assistance, financial or otherwise, to such people's and non-governmental organizations for

economic, socially-oriented, environmental, or cultural projects to be implemented within its territorial jurisdiction" thus, such donation is in accordance with the said law.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to donate, as it does hereby donate, eighty three (83) units of basketball board to qualified subdivisions located in Barangay Batasan Hills, Barangay Holy Spirit, Barangay Bagong Silangan, Barangay Commonwealth and Barangay Payatas.

RESOLVED, FURTHER, that the ownership of the basketball boards be transferred to the recipients through a Deed of Donation.

RESOLVED, FINALLY, that the copies of this Resolution, along with the Deed of Donation, be furnished to the Office of Councilor Precious Hipolito Castelo, the City General Services Department, and the recipients of the basketball boards for future reference.
