RESOLUTION NO. SP- 7156, S-2017

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO EXTEND FINANCIAL ASSISTANCE OF FIVE THOUSAND PESOS (PHP5,000.00) TO EACH OF THE FOUR HUNDRED NINETY EIGHT (498) INFORMAL SETTLER FAMILIES (ISFs) LIVING ALONG BALONBATO CREEK AND UNDER THE CAMACHILE FLYOVER WHO ARE ABOUT TO BE RELOCATED TO NATIONAL HOUSING AUTHORITY (NHA) RESETTLEMENT SITE IN MORONG, PROVINCE OF RIZAL, EQUIVALENT TO A TOTAL AMOUNT OF TWO MILLION FOUR HUNDRED NINETY THOUSAND PESOS (PHP2,490,000.00).

WHEREAS, a total of 498 informal settler families (ISFs) were verified to be living along Balonbato creek and under Camachile Flyover located in Barangay Unang Sigaw and Barangay Balonbato:

WHEREAS, the said areas, which are considered high risk, had been the subject of many clearing operations in the past, but due to insistence of ISFs to re-occupy the areas, lack of monitoring and prevention efforts on the part of the government as well as lack of development in said areas, the same remain blighted until today;

WHEREAS, in an effort to relocate ISFs to a safer ground and finally clear the subject areas, the Quezon City Government has negotiated for the relocation of all the affected ISFs to an NHA resettlement site in Morong, Rizal;

WHEREAS, to draw cooperation from the affected ISFs and also to provide them with something to start with at the resettlement site, there is a need for the Quezon City Government to allocate and extend financial assistance fund to the 498 affected ISFs in the total amount of Php2,490,000.00 or an equivalent amount of Php5,000.00 per ISF;

WHEREAS, Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, "The City Mayor shall represent the City in all business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance".

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M Bautista, to extend financial assistance of Five Thousand Pesos (Php5,000.00) to each of the Four Hundred Ninety Eight (498) informal settler families (ISFs) living along Balonbato Creek and under the Camachile Flyover who are about to be relocated to National Housing Authority (NHA) resettlement site in Morong, Province of Rizal, equivalent to a total amount of Two Million Four Hundred Ninety Thousand Pesos (Php2,490,000.00).
