A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PROCURE FIVE (5) UNITS OF MOTORIZED VEHICLE, TO BE DONATED TO AND UTILIZED BY THE QUEZON CITY POLICE DISTRICT. (QCPD), FOR THE EFFECTIVE IMPLEMENTATION OF THEIR OPERATIONS AND LAW ENFORCEMENT ACTIVITIES, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, Section 17(b) (4) (ii) of the Local Government Code of 1991 identifies the basic services and facilities that local government unit are mandated to efficiently and effectively provide to its constituents, which basic services and facilities include "support for education, police and fire services and facilities";

WHEREAS, the donation of the said motor vehicles to the QCPD will further enhance police mobility and shorten response time, boost police morale and inspire better and more improved performance as well as further show the Quezon City Government's support for the maintenance of peace, law and order;

WHEREAS, Section 455 (b) (1) (vi) of the same Code also states that, "The City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance";

Bautista, to procure Five (5) units of motorized vehicles, to be donated to and utilized by the Quezon City Police District (QCPD), for the effective implementation of their operations and law enforcement activities, subject to existing laws, rules and regulations.
