WHEREAS, the Quezon City Police District's mission and vision for our constituents is "to provide quality service which will make Quezon City an ideal community where people live, work and do business in a hospitable, progressive and peaceful environment";

WHEREAS, the City Mayor, Honorable Herbert M. Bautista, has lauded the QCPD personnel for their valuable service to the Quezon City residents and he challenged them to work harder to maintain peace and order;

WHEREAS, the donation of the said motor vehicles for the QCPD are necessary to ensure their mobility and efficient response time, inspire the police force and as well as further show the Quezon City Government's support for the maintenance of peace, and order;

WHEREAS, Mayor Herbert M. Bautista is authorized to donate Six (6) units of Motorized Vehicle to the Quezon City Police District (QCPD), for the effective implementation of their operations and law enforcement activities, subject to laws, rules and regulations,

WHEREAS, the motor vehicle requested shall have the following description, to wit:






