RESOLUTION NO. SP- 7214, S-2017

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO VICTORY LINER, INC. FOR THE OPERATION OF A BUS TERMINAL STATION LOCATED ALONG EPIFANIO DELOS SANTOS AVENUE (EDSA), BARANGAY PINYAHAN, QUEZON CITY.

WHEREAS, Petitioner Victory Liner, Inc., a duly registered business entity under Philippine law, is applying for the issuance of a Special Use Permit (SUP) for the operation of a bus terminal station located along EDSA, Barangay Pinyahan, Quezon City;

WHEREAS, the existing bus terminal, equipped with CCTV cameras, includes ticketing and shipping booth, cashier's office, clean restrooms, convenient store, sleeping quarters, baggage area, and parking area;

WHEREAS, Transport Terminals are among the uses which require a Special Use Permit subject to an authorization from the Quezon City Council through a Resolution, as contemplated in Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance, as amended;

WHEREAS, Victory Liner, Inc. has complied with the requirements for the issuance of a Special Use Permit as specified by the aforementioned Ordinance;

WHEREAS, the operation of this transport terminal and garage is in accord with the promotion of public welfare and economic development of our city;

WHEREAS, the said operation does not adversely affect public health, safety and welfare, and is not detrimental to the use of adjoining property and existing servitudes.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Special Use Permit to Victory Liner, Inc. for the operation of a bus terminal station with the incidental amenities and facilities abovementioned, located along Epifanio Delos Santos Avenue (EDSA), Barangay Pinyahan, Quezon City.

RESOLVED, FURTHER, that the Special Use Permit shall be automatically or ipso facto revoked upon the enactment of a national law or executive order prohibiting garage terminal along EDSA.

RESOLVED, FURTHERMORE, that the prescriptive period of this Resolution is three (3) years from the date of approval.
