RESOLUTION NO. SP- 7235 , S-2017

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA TO EXTEND FINANCIAL ASSISTANCE OF FIVE THOUSAND PESOS (PHP5,000.00) TO EACH OF THE ONE HUNDRED THIRTY-SEVEN (137) INFORMAL SETTLER FAMILIES (ISFs) TO BE AFFECTED BY THE CONSTRUCTION OF THE UP EMPLOYEES HOUSING PROJECT LOCATED IN BARANGAY UP CAMPUS, QUEZON CITY, WHO ARE ABOUT TO BE RELOCATED TO NHA RESETTLEMENT SITE IN MORONG, RIZAL, EQUIVALENT TO A TOTAL AMOUNT OF SIX HUNDRED EIGHTY FIVE THOUSAND PESOS (PHP685,000.00).

WHEREAS, a total of 137 informal settler families (ISFs) were verified living along and on top of U.P. Employees Housing Project located in Barangay UP Campus, Quezon City;

WHEREAS, to give way to the development of the aforementioned housing project, there is a need to relocate the 137 affected ISFs to any of the available NHA Resettlement Site;


WHEREAS, to draw cooperation from the affected ISFs and also to provide them with something to start with at the resettlement site, there is a need for the Quezon City Government to allocate and extend financial assistance fund to the 137 affected ISFs in the total amount of Php685,000.00 or an equivalent amount of Php5,000.00 per affected ISF; ✓

WHEREAS, pursuant to Section 455 (b)(1)(vi) of R.A. No. 7160 otherwise known as the Local Government Code of 1991, states that, "the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance".


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to extend financial assistance of Five Thousand Pesos (Php5,000.00) to each of the One Hundred Thirty-Seven (137) informal settler families (ISFs) to be affected by the construction of the UP Employees Housing Project located in Barangay UP Campus, Quezon City, who are about to be relocated to NHA Resettlement Site in Morong, Rizal, equivalent to a total amount of Six Hundred Eighty-Five Thousand Pesos (Php685,000.00).


