RESOLUTION NO. SP- **7236** , S-2017

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE ELEVEN (11) UNITS OF MOTOR VEHICLES INTENDED FOR THE MONITORING OF PROGRAMS AND PROJECTS OF THE CITY COUNCIL, AMOUNTING TO FOURTEEN MILLION FOUR HUNDRED TEN THOUSAND PESOS (PHP14,410,000.00) TO BE CHARGED FROM THE OFFICE OF THE CITY COUNCILORS FUND, QUEZON CITY.

WHEREAS, pursuant to Administrative Order No. 1 amending Administrative Order No. 233, Series of 2008, the City Mayor, Honorable Herbert M. Bautista has already sought permission and authorization from DILG in his letter addressed to Mr. Juan Jovian E. Ingeniero CESO IV, City Director of DILG for the acquisition of the above-described motor vehicles which amount is included in the 2017 Annual Budget of the City Government;

WHEREAS, pursuant to Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance. *h*
