A RESOLUTION GRANTING A MARKET FRANCHISE TO SEAHORSE REALTY CORPORATION FOR THE OPERATION OF SUPER PALENGKE LOCATED AT GRANTS STREET CORNER BENEFITS STREET, GSIS VILLAGE, BARANGAY SANGANDAAN, QUEZON CITY, IN ACCORDANCE WITH AND SUBJECT TO THE PERTINENT PROVISIONS OF ORDINANCE NO. SP-2459, S-2015, OTHERWISE KNOWN AS THE REVISED QUEZON CITY MARKET CODE.

WHEREAS, City Ordinance No. SP-2459, S-2015, otherwise known as the Revised Market Code, was enacted by the Quezon City Council in order to integrate all Laws and Ordinances for a more efficient and organized system of regulation of public markets and market-related activities to safeguard the interest of consumers;

WHEREAS, it is the legislative intent of the Quezon City Council to require all existing private markets to secure a market franchise from the Quezon City Council pursuant to City Ordinance No. SP-2459, S-2015, otherwise known as the Revised Market Code;

WHEREAS, Article III, Section 1, paragraph 1.4 of City Ordinance No. SP-2459, S-2015, otherwise known as the Revised Market Code, provides that no person, partnership or corporation shall operate a private market within Quezon City without first securing a franchise from the City Council;

WHEREAS, Super Palengke is an existing wet and dry market located at Grants Street corner Benefits Street, GSIS Village, Barangay Sangandaan, Quezon City, being operated by Seahorse Realty Corporation;

WHEREAS, Seahorse Realty Corporation has complied with all the documents necessary for the operations of a private market that will entitle the corporation to be granted with a market franchise by the Quezon City Council pursuant to City Ordinance No. SP-2459, S-2015, otherwise known as the Revised Market Code.

NOW, THEREFORE.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant market franchise to Seahorse Realty Corporation for the operation of Super Palengke located at Grants Street corner Benefits Street, GSIS Village, Barangay Sangandaan, Quezon City, in accordance with and subject to the pertinent provisions of Ordinance No. SP-2459, S-2015, otherwise known as the Revised Quezon City Market Code.
