WHEREAS, under Republic Act No. 7160, "the City Council has the authority to grant franchises, enact ordinances authorizing the issuance of permits or licenses and levying taxes, fees and other charges";

WHEREAS, the petitioner 14 Susano Novaliches Gas Station with Company Reg. No. CS201721198 and Company TIN No. 009-720-010, a business entity duly registered under the Philippine Laws, is applying for a Special Use Permit for the construction and operation of a gasoline refilling station which shall be located at No. 45 Susano Road, Barangay Novaliches Proper, District V, Quezon City;

WHEREAS, the Sangguniang Barangay of Novaliches Proper, interposes no objection to the proposed construction of the gasoline refilling station because of the benefits and development that would be realized and input of the said project;

WHEREAS, the Sangguniang Barangay of Novaliches Proper with proper notice and consultation among the neighboring residents was properly conducted and interposes no objection to the construction of the gasoline refilling station;
