

WHEREAS, Republic Act No. 10742, otherwise known as the Sangguniang Kabataan (SK) Reform Act of 2015, and its Implementing Rules and Regulations provides for the creation of a Youth Development Office in every Province, City and Municipality;

WHEREAS, the Department of the Interior and Local Government in Memorandum Circular No. 2017-36 dated 24 February 2017 directed all Provincial Governors, City/Municipal Mayors and all other concerned to create their respective Local Youth Development Office within their areas of jurisdiction;

WHEREAS, on 3 April 2017, the Department of the Interior and Local Government rissued Memorandum Circular No. 2017-57 providing for the guidelines on the utilization of the Sangguniang Kabataan Funds for FY 2017;

WHEREAS, the said Memorandum Circular provides that pending the election and qualification of the new set of SK Officials, all Punong Barangays and Sangguniang Barangay Members are directed to use the ten percent (10%) SK Funds in accordance with the attached guidelines (Annex A "Excerpts from the Minutes of the Regular En Banc Meeting of the Commission on Elections held on 28 February 2017).

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the City Mayor, Honorable Herbert M. Bautista to create a Quezon City Youth Secretariat.
