A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO SIGN THE DEEDS OF DONATION IN FAVOR OF SEVERAL GOVERNMENT INSTITUTIONS AND NON-GOVERNMENTAL ORGANIZATIONS IN DISTRICT 5, QUEZON CITY, FOR THE DONATION OF FORTY (40) UNITS OF COMPUTER SETS AND AUTHORIZING THE TRANSFER OF OWNERSHIP TO SAID INSTITUTIONS WITHOUT COST.

NOW, THEREFORE,




