RESOLUTION NO. SP- 7397 ..., S-2018

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO LUWELL REALTY AND DEVELOPMENT CORPORATION FOR THE CONSTRUCTION OF A TWO (2)-STOREY BUILDING AND GROUND FLOOR PARKING LOCATED AT LOTS 3 AND 5, BLOCK 4, BUKIDNON CORNER ANTIQUE STREET, BARANGAY RAMON MAGSAYSAY, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Krystle Ann K. Chua, Corporate Secretary of Luwell Realty Development Corporation is applying for a Certificate of Exception for the construction of a Two (2)-Storey Building and Ground Floor Parking to be located at Lots 3 and 5 Block 4, Bukidnon corner Antique Street, Barangay Ramon Magsaysay, Quezon City;
