A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO RYOAKI GAS STATION, INC., FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE REFILLING STATION TO BE LOCATED AT LOT 5 BLOCK 237 COMMONWEALTH AVENUE EXTENSION BRITTANY IV, BARANGAY PASONG PUTIK, QUEZON CITY.

WHEREAS, petitioner Ryoaki Gas Station, Inc., with office address at No. 182 Angelina Canaynay Avenue, San Dionisio, Parañaque City, is applying for a Special Use Permit for the construction and operation of a gasoline refilling station which shall be located at Lot 5, Block 237 Commonwealth Avenue Extension, Brittany IV, Barangay Pasong Tamo, Quezon City;

WHEREAS, fuel stations are among the uses that require Special Use Permit only upon authorization from the Quezon City Council pursuant to Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016;
