A RESOLUTION GRANTING A MARKET FRANCHISE TO MR. BENNET V. MELENCIO FOR THE OPERATION OF WET AND DRY MARKET LOCATED AT LOTS 1 AND 2 BLOCK 145 PIOPONGCO STREET CORNER CAPILLAN STREET, BARANGAY SAN ANTONIO, QUEZON CITY, IN ACCORDANCE WITH AND SUBJECT TO THE PERTINENT PROVISIONS OF ORDINANCE NO. SP-2459, S-2015, OTHERWISE KNOWN AS THE REVISED QUEZON CITY MARKET CODE.

WHEREAS, City Ordinance No. SP-2459, S-2015, otherwise known as the Revised Market Code, was enacted by the Quezon City Council in order to integrate all laws and ordinances for a more efficient and organized system of regulation of public markets and market-related activities to safeguard the interest of consumers;

WHEREAS, it is the legislative intent of the Quezon City Council to require all existing private markets to secure a market franchise from the Quezon City Council pursuant to City Ordinance No. SP-2459, S-2015, otherwise known as the Revised Market Code;

WHEREAS, Section 1, Paragraph 1.4 Article III, of City Ordinance No. SP-2459, S-2015, otherwise known as the Revised Market Code, provides that no person, partnership or corporation shall operate a private market within Quezon City without first securing a franchise from the City Council;

WHEREAS, the Wet and Dry Market located at Lots 1 and 2 Block 145 Piopongco Street corner Capillan Street, Barangay San Antonio, Quezon City, is being operated by Mr. Bennet V. Melencio;


WHEREAS, Mr. Bennet V. Melencio has complied with all documents necessary for the operations of a private market that will entitle the person to be granted with a market franchise by the Quezon City Council pursuant to City Ordinance No. SP-2459, S-2015, otherwise known as the Revised Market Code.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant a market franchise to Mr. Bennet V. Melencio for the operation of Wet and Dry Market located at Lots 1 and 2 Block 145 Piopongco Street corner Capillan Street, Barangay San Antonio, Quezon City, in accordance with and subject to the pertinent provisions of Ordinance No. SP-2459, S-2015, otherwise known as the Revised Quezon City Market Code.

RESOLVED, FURTHER, that the market franchise granted under this Resolution shall be for a period of five (5) years and subject to franchise fee and annual franchise tax provided under Section 1, Paragraphs 1.4.1 and 1.4.3 Article III, of City Ordinance No. SP-2459, S-2015, otherwise known as the Revised Market Code.
