A RESOLUTION GRANTING A CERTIFICATE OF EXCEPTION TO SAVORY FASTFOOD INC., REPRESENTED BY MR. KRISTOFERSON DAVY L. TING FOR THE RENOVATION OF TWO (2)-STOREY OFFICE BUILDING LOCATED AT LOT 36 BLOCK 105 SAN ANTONIO STREET, BARANGAY SAN ANTONIO, QUEZON CITY, SUBJECT TO THE PROVISIONS OF THE QUEZON CITY'S COMPREHENSIVE ZONING ORDINANCE OF 2016 AND SUCH OTHER EXISTING LAWS APPLICABLE.

Ting, owner, requested for the issuance of a Certificate of Exception for the renovation of two (2)-storey office building located at Lot 36, Block 105, San Antonio Street, Barangay San Antonio, Quezon City, because the project type is not permissible in the zone classification (high density residential zone R-3) as per evaluation and notice/advice of action (CN IC16-Z-02529) dated September 7, 2016 issued by the City Planning and Development Office, Zoning Administration Unit;
