RESOLUTION NO. SP. 7441 , S-2018

A RESOLUTION RATIFYING THE TURN-OVER AND CONVERSION OF THREE (3) LOCAL ROADS SPECIFICALLY SB DIVERSION ROAD. BELFAST STREET/WYE LENGTH AND MINDANAO AVENUE EXTENSION INTO NATIONAL ROADS.

WHEREAS, first comprehensive reference to a Road Classification System is found in Republic Act No. 917, known as the Philippine Highway Act, enacted in 1953 and Executive Order (EO) No. 113, Series of 1955, EO No. 113 also laid down criteria for classification of national roads and for reclassification from local roads to national roads;

WHEREAS, by virtue of Executive Order No. 124, Series of 1978, the Department of Public Works and Highways (DPWH), was given the power to classify roads and highways and also to provide and authorize the conversion of roads and highways from one category to another;

WHEREAS, as requested by Representative Alfredo D. Targos III. 5" District of Quezon City, the three (3) local roads specifically SB Diversion Road, Belfast Street/Wye Length and Mindanao Avenue Extension passed the DPWH Functional Classification Criteria for conversion into national roads;

WHEREAS, SB Diversion Road is meritorious for conversion into a national road based on functionality for it serves as a bypass road to Quirino Highway Secondary Road that links to General Luis Secondary Road while Mindanao Avenue Secondary Road leading to the northern part of Luzon in Bulacan and Pumpanga, among others, via NLEX alleviates traffic congestion along General Luis Secondary Road and Novaliches Proper without interference from local traffic to improve road safety;

WHEREAS, Belfast Street/Wye Length and Mindanao Avenue Extension are also meritorious for conversion into national roads based on their functionality since they serve as a vital thoroughfare to mitigate and ease traffic in Fairview, Quezon City.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to ratify, as it does hereby mailing the turn-over and conversion of three (3) local roads specifically SB Diversion Road, Belfast Street/Wye Length and Mindanao Avenue Extension into national roads.
