RESOLUTION NO. SP. 7459 S-2018

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT (QCG), THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO GRANT FINANCIAL ASSISTANCE TO THE "DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT-NATIONAL CAPITAL REGION (DILGNCR)", IN THE AMOUNT OF TEN MILLION PESOS (PHP10,000,000.00), SUBJECT TO THE EXISTING ACCOUNTING AND AUDITING LAWS, RULES AND REGULATIONS.

WHEREAS, the DILG through the LGA is currently leading the development and implementation of information and education campaign and the technical studies for the transition of a federal form of government to ensure that the proposed transition will be a smooth and based on policies backed by sound research and the latest available information, data and sources;

WHEREAS, President Rodrigo Roa Duterte has appointed Mayor Herbert M. Bautista as Chairperson of the Regional Peace and Order Council in the National Capital Region (RPOC-NCR);

WHEREAS, Honorable Herbert M. Bautista, in his capacity as Mayor, acceded to assist the Regional Peace and Order Council - National Capital Region by way of granting financial assistance in the amount of Php 10,000,000.00 to carry out its mandate activities;

WHEREAS, the donation of the said amount is necessary to promote and provide support to the Regional Peace and Order Council in the National Capital Region (RPOC-NCR) in favour of the Department of the Interior and Local Government – National Capital Region (DILG-NCR) to attain its mandate and objectives.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Quezon City Government (QCG), through the City Mayor, Honorable Herbert M. Bautista, to grant financial assistance to the "Department of the Interior and Local Government-National Capital Region (DILG-NCR)", in the amount of Ten Million Pesos (Php10,000,000.00), subject to the existing accounting and auditing laws, rules and regulations.
