RESOLUTION NO. SP- **7459**, S-2018

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT (QCG), THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO GRANT FINANCIAL ASSISTANCE TO THE "DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT-NATIONAL CAPITAL REGION (DILG-NCR)", IN THE AMOUNT OF TEN MILLION PESOS (PHP10,000,000.00), SUBJECT TO THE EXISTING ACCOUNTING AND AUDITING LAWS, RULES AND REGULATIONS.




NOW, THEREFORE,


