A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH VARSITY HILLS SUBDIVISION HOMEOWNERS ASSOCIATION, XAVIERVILLE 1 HOMEOWNERS ASSOCIATION AND XAVIERVILLE 2 HOMEOWNERS ASSOCIATION, BARANGAY LOYOLA HEIGHTS, QUEZON CITY, TO CONTINUE MAINTAINING AND IMPROVING THEIR EXISTING STEEL GATES.

WHEREAS, the Local Government Code of 1991empowers the Local Government Units to enact measures necessary to promote the health and safety, maintain peace and order and preserve the comfort and convenience of the inhabitants;

WHEREAS, the security gates within the community of Varsity Hills Subdivision, Xavierville 1 Subdivision and Xavierville 2 Subdivision were put up more than thirty (30) years ago and approved by the then Mayor Ismael Mathay, Jr.;

WHEREAS, the road lots in Varsity Hills Subdivision, Xavierville 1 Subdivision and Xavierville 2 Subdivision were donated to the Quezon City Government;

WHEREAS, the abovementioned security gates are very old and it may no longer serve its purpose;

WHEREAS, the Varsity Hills Homeowners Association, Xavierville 1 Homeowners Association and Xavierville 2 Homeowners Association have been maintaining and improving the said steel gates since the time it was built,

WHEREAS, a Public Consultation was held wherein the representatives from Varsity Hills Homeowners Association, Xavierville 1 Homeowners Association and Xavierville 2 Homeowners Association were present as well as the representatives from the City Planning, Building and Zoning and General Services Department;

WHEREAS, no objection was manifested by the representatives from the City Planning Building and Zoning and General Services Department;

WHEREAS, the representatives from Varsity Hills Homeowners Association, Xavierville 1 Homeowners Association and Xavierville 2 Homeowners Association, through the initiative of its members and residents, would like to make an improvement on the said steel gates situated on the road lots donated to the Quezon City Local Government;

WHEREAS, a Memorandum of Agreement between the Quezon City Local Government and Varsity Hills Homeowners Association, Xavierville 1 Homeowners Association and Xavierville 2 Homeowners Association is a requirement in order for them to legally maintain and improve their security gates.
