RESOLUTION NO. SP- 7470 , S-2018

A RESOLUTION STRONGLY SUPPORTING THE PASSAGE OF SENATE BILL NO. 1390, ENTITLED "AN ACT STRENGTHENING COMPREHENSIVE POLICYPHILIPPINEACQUIRED ANDIMMUNODEFICIENCY (HIV) VIRUS IMMUNODEFICIENCY SYNDROME (AIDS) PREVENTION, TREATMENT, CARE, AND SUPPORT, AND ESTABLISHING THE PHILIPPINE NATIONAL AIDS COUNCIL (PNAC), REPEALING FOR THE PURPOSE, REPUBLIC ACT NO. 8504, OTHERWISE KNOWN AS THE PHILIPPINE ACT OF 1998, AND PREVENTION AND CONTROL APPROPRIATING FUNDS THEREFOR."

WHEREAS, Section 15, Article II of the 1987 Constitution declares that "The State shall protect and promote the right to health of the people and instill health consciousness among them. "Also, Article XIII, on Social Justice and Human Rights on Health, declares that it is the responsibility of the State to "adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost";

WHEREAS, the UNAIDS report showed a 140-percent increase in the number of new infections in the Philippines for the past six years from an estimated 4,300 in 2010 to cound 10,500 in 2016; y

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to support, as it does hereby strongly support the passage of Senate Bill No. 1390, entitled, "An Act Strengthening The Philippine Comprehensive Policy On Human Immunodeficiency Virus (HIV) And Acquired Immunodeficiency Syndrome (AIDS) Prevention, Treatment, Care, And Support, And Establishing The Philippine National Aids Council (PNAC), Repealing For The Purpose Republic Act No. 8504, Otherwise Known As The Philippine Aids Prevention And Control Act Of 1998, and Appropriating Funds Therefor."
