RESOLUTION NO. SP- **7490**, S-2018

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE INTENDED FOR THE MONITORING OF PROGRAMS AND PROJECTS OF THE OFFICE OF COUNCILOR PRECIOUS HIPOLITO CASTELO TO BE CHARGED TO THE FUNDS OF THE OFFICE OF THE CITY COUNCILOR.


NOW, THEREFORE,
