RESOLUTION NO. SP- **7493** S-2018

A RESOLUTION AMENDING SECTION 13, PARAGRAPH 29 OF RESOLUTION NO. SP-6824, S-2016, OTHERWISE KNOWN AS A RESOLUTION ADOPTING THE INTERNAL RULES OF PROCEDURE OF THE 20<sup>TH</sup> QUEZON CITY COUNCIL AND BY ADDING PARAGRAPH 38 THEREOF.

WHEREAS, Section 16 of Republic Act No. 7160 provides in part that every local government unit shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of general welfare;

WHEREAS, to better achieve these objectives, Section 50 of Republic Act No. 7160 likewise gives the City Council of Quezon City the power to promulgate, adopt and update its existing rules of procedure, including those referring to the legislative process:

WHEREAS, the Sangguniang Kabataan elections was held last May 14, 2018;

WHEREAS, the Sangguniang Kabataan Federation of Quezon City held their elections last May 28, 2018 and subsequently elected their officers last May 29, 2018;

WHEREAS, the Second sentence of Paragraph B in Title II, Chapter I, Section 41 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that: xxx The presidents of the "liga ng mga barangay and the pederasyon ng mga sangguniang kabataan" elected by their respective charters, as provided in this Code, shall serve as ex officio members of the sangguniang panlalawigan, sangguniang panlungsod, and sangguniang bayan xxx;

WHEREAS, the elected President of the Sangguniang Kabataan Federation of Quezon City shall be an ex officio member of the 20<sup>th</sup> City Council of Quezon City;

WHEREAS, the President of the Sangguniang Kabataan Federation of Quezon City automatically becomes the Chairman of the Committee on Youth and Sports;

WHEREAS, there is a need to amend Resolution No. SP-6824, S-2018, otherwise known as the Resolution Adopting the Internal Rules and Procedure of the 20<sup>th</sup> Quezon City Council, Section 13 Paragraph 29 and add Paragraph 38, thereby adding a Committee:

WHEREAS, Section 13 Paragraph 29 of Resolution No. SP-6824, S-2018 should be read as:

"COMMITTEE ON SENIOR CITIZENS AFFAIRS - All matters involving protection, development and welfare of the Senior Citizens. To conduct studies and research as well as to propose legislations and actions relative to protection, promotion and enhancement of the welfare of senior citizens"

WHEREAS, additional Paragraph in Section 13 of Resolution No. SP-6824, S-2018, Paragraph 38 should be read as:

"COMMITTEE ON PEOPLE WITH SPECIAL CHALLENGES - Conduct studies and research, as well as to propose legislations and actions in all matters involving People with Special Challenges for the purpose of developing their skills and human resourcefulness, with the end view of uplifting their socio economic condition or standard of living and for them to gain self confidence, respect and dignity." †






NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to amend, as it does hereby amend Section 13 of Resolution No. SP-6824, S-2016, otherwise known as a Resolution Adopting the Internal Rules of Procedure of the 20<sup>th</sup> Quezon City Council, amending for the purpose Paragraph 29 as a Committee solely for Senior Citizen and thereby adding Paragraph 38 as a Committee solely for People with Special Challenges.


