WHEREAS, Deputy City Prosecutor Rogelio A. Velasco, popularly known as "DCP Velasco" who had faithfully served Quezon City in various capacities, died on May 11, 2018 at the age of Sixty Four (64) years old;

WHEREAS, the late DCP Rogelio A. Velasco was born on April 20, 1954 in La Paz, Abra but spent most of his life in this City. From humble beginnings, he successfully carved a name for himself through hard work and dedicution as an exemplary public servant;

WHEREAS, the late DCP Rogelio A. Velasco finished his secondary education, a Valedictorian, at the Queen of Peace High School in 1970 and was conferred a Bachelor's Degree in Political Science by the University of the Philippines in 1974. He finished his Bachelor of Laws also in the University of the Philippines in 1978, and a year thereafter, became a lawyer;
