WHEREAS, a modern laboratory and radiology equipment is used to perform complete blood count, blood sugar determination, blood typing, pregnancy test, urinalysis as well as ultrasound, 2D echo and ECG were also made available for free;

WHEREAS, the result of the Iglesia Ni Cristo's successful Worldwide Walk Against Poverty last May 2018 has allowed it to hold even more Lingap sa Mamamayan by the funds raised in the said activity;

WHEREAS, with this exemplary showing of unconditional and continuous mission in helping the Filipino people, it is just fitting for the Quezon City Council to commend the Iglesia Ni Cristo with the leadership of Brother Eduardo V. Manalo in another successful staging of the Lingap sa Mamamayan activity.
