A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO PETRON CORPORATION, FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE REFILLING STATION TO BE LOCATED ALONG QUIRINO HIGHWAY, BARANGAY KALIGAYAHAN, NOVALICHES, DISTRICT V, QUEZON CITY.

WHEREAS, petitioner Petron Corporation, a business entity duly registered under Philippine Laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of a gasoline refilling station to be located along Quirino Highway, Barangay Kaligayahan, Novaliches, District V, Quezon City;

WHEREAS, the Sangguniang Barangay of Barangay Kaligayahan interposes no objection to the proposed construction because of the benefits and development that would be realized out of the said project and public hearing was properly conducted and obtained favorable approval of the residents therein;
