A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO GRANT FINANCIAL ASSISTANCE AMOUNTING TO TWO HUNDRED FIFTY THOUSAND PESOS (PHP250,000.00) IN FAVOR OF THE ASSOCIATION OF BARANGAY CAPTAINS (ABC) OF DISTRICT 1, QUEZON CITY, SUBJECT TO EXISTING ACCOUNTING AND AUDITING LAWS, RULES, AND REGULATIONS, AS WELL AS SUBMISSION OF AUDITED FINANCIAL STATEMENTS, AND LIQUIDATION REQUIREMENTS.

WHEREAS, the donation of the said amount is necessary to promote and provide support to a civic organization to attain its objectives.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to grant financial assistance amounting to Two Hundred Fifty Thousand Pesos (Php250,000.00) in favor of the Association of Barangay Captains (ABC) of District 1, Quezon City, subject to existing Accounting and Auditing Laws, Rules, and Regulations, as well as submission of audited financial statements, and liquidation requirements.
