A RESOLUTION AMENDING RESOLUTION NO. SP-4804, S-2010 BY CHANGING THE NAME OF THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE JR., TO HONORABLE HERBERT M. BAUTISTA AND THE HOUSING PROGRAM TO BE UNDERTAKEN BY THE QUEZON CITY GOVERNMENT FROM THE COMMUNITY MORTGAGE PROGRAM TO ANY SOCIALIZED HOUSING PROJECT.

LIGAN, FOR SALE UNDER THE COMMUNITY MORTGAGE PROGRAM (CMP) OR OTHER GOVERNMENT HOUSING PROGRAM TO THE BONAFIDE RESIDENTS THEREIN";

WHEREAS, there is also a need to amend the housing program to be undertaken in order to implement the socialized housing project in favor of the occupants.


NOW, THEREFORE,


