A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO PETRON CORPORATION, FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE REFILLING STATION TO BE LOCATED AT REGALADO AVENUE CORNER PONTIAC STREET, BARANGAY FAIRVIEW, DISTRICT V, QUEZON CITY.

WHEREAS, the Sangguniang Barangay of Barangay Fairview interposes no objection to the proposed construction because of the benefits and development that would be realized out of the said project and public hearing was properly conducted and obtained favorable approval of the residents therein;


