A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO SEAOIL PHILIPPINES, INC., FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE FILLING STATION WHICH SHALL BE LOCATED AT LOT 10, BLOCK 3, CONGRESSIONAL AVENUE EXTENSION, BARANGAY PASONG TAMO, QUEZON CITY.

WHEREAS, Petitioner Seaoil Philippines Inc., a business entity duly registered under Philippine Laws is applying for a Special Use Permit (SUP) to be used for the construction and operation of a gasoline filling station which shall be located at Lot 10, Block 3, Congressional Avenue Extension, Barangay Pasong Tamo, Quezon City;

WHEREAS, fuel stations are among the uses that require a Special Use Permit only upon authorization from the Quezon City Council pursuant to Ordinance No. SP-2502, S-2016, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2016;
