RESOLUTION NO. SP-**7677**, S-2018

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE METROPOLITAN WATERWORKS AND SEWERAGE SYSTEM (MWSS) AND MANILA WATER COMPANY, INC. FOR THE CONSTRUCTION OF PARK FACILITIES AT E. RODRIGUEZ SR. AVENUE TO AURORA BOULEVARD, BARANGAY IMMACULATE CONCEPTION, N. DOMINGO STREET AND MAIN HORSESHOE DRIVE, BARANGAY HORSESHOE, AND GRANADA STREET, BARANGAY VALENCIA, QUEZON CITY.

WHEREAS, the Metropolitan Waterworks and Sewerage System (MWSS) owns three (3) real properties (collectively referred herein as "The Properties") located at the following areas within the jurisdiction of Quezon City:

1. Aqueduct right-of-way with an area of 3,000 square meters at the stretch of E. Rodriguez Sr. Avenue to Aurora Boulevard, Barangay Immaculate Conception;
2. Aqueduct right-of-way with an area of 1,200 square meters at the corner of N. Domingo Street and Main Horseshoe Drive, Barangay Horseshoe; and
3. Aqueduct right-of-way with an area of 1,200 square meters at Granada Street, Barangay Valencia.


WHEREAS, the MWSS has agreed to the proposal of the Quezon City Government to construct and develop park facilities composed of Open Basketball Courts, Playgrounds and Strolling Areas "Park Facilities" to maintain the orderliness and cleanliness of the aforementioned properties after clearing the same from the existence of illegal structures;   

WHEREAS, a Memorandum of Agreement (MOA) specifying the respective rights and obligations of the parties will be executed between and among the Quezon City Government, MWSS and Manila Water Company, Inc.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to sign and enter into a Memorandum of Agreement (MOA) with the Metropolitan Waterworks and Sewerage System (MWSS) and Manila Water Company, Inc. for the construction of park facilities at E. Rodriguez Sr. Avenue to Aurora Boulevard, Barangay Immaculate Conception, N. Domingo Street and main Horseshoe Drive, Barangay Horseshoe, and Granada Street, Barangay Valencia, Quezon City.


