Its aim is to generate interests in robotics in the young minds. FIRA believes that these interests will fuel scientific and engineering skills that ultimately develop into research outcomes to serve mankind in a variety of ways;

WHEREAS, SMC-QC Robotics Team has won First place in the Youth Category: Disaster Risk Challenge in the 23rd FIRA RoboWorld Cup held last August 6-12, 2018 at Feng Chia University, Taichung, Taiwan. The SMC-QC Robotics team was composed of three (3) students from Elementary and High School. The team members were: Andrea Joy Abergas, Anya Clarissa Legaspi, and Mikaela Jaymee Balabat, together with their coaches Mrs. Fides Balatbat and Sherry Salinel;

WHEREAS, International Robot Olympiad (IRO) Camp and Competition is a prelude to the 20th IRO World Championships. The IRO camp and competition hosted an array of robot trainings and competitions for delegates from Japan, Korea, China, Philippines, Thailand, HongKong, Indonesia, Malaysia, Taiwan, Bangladesh and Costa Rica:
