A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, ON BEHALF OF THE QUEZON CITY GOVERNMENT, TO ACCEPT THE DONATION OF TEN (10) UNITS OF 14-INCH HAIER LAPTOP WITH BUILT-IN CAMERA AND WIRELESS MOUSE AND HEADPHONES FROM THE DEPARTMENT OF INFORMATION AND COMMUNICATIONS TECHNOLOGY, REPRESENTED BY ITS SECRETARY, IVAN JOHN UY, AND EXECUTE THE RELATED DEED OF DONATION FROM THE DONOR, WITH THE OBJECTIVE OF PARTICIPATING IN THE DEPARTMENT'S DIGITAL EDUCATION PROGRAM AND ITS COMPONENT EXPANDED PILOT CYBERSAFE LEARNING FOR EDUCATION PROJECT, AND OTHER GOVERNMENT PURPOSE.

WHEREAS, Republic Act No. 10844, otherwise known as the Department of Information and Communications Technology Act of 2015, provides that it is a state policy to promote digital literacy, information and communications technology (ICT) expertise, and knowledge-building among citizens to enable them to participate and compete in an evolving ICT age;

WHEREAS, on June 12, 2020, the Department of Information and Communications Technology issued Circular No. 12, accelerating the implementation of the Digital Education Program and its component projects in response to the state of public health emergency due to Coronavirus Disease 2019 (COVID-19);

WHEREAS, the Department of Information and Communications Technology is willing to accommodate the Quezon City Government to its Digital Education Program and its component Expanded Pilot Cybersafe Learning for Education Project and, in consideration thereof, will provide the City Government with necessary equipment in pursuance therewith;

WHEREAS, the Quezon City Government acknowledges that the pandemic has accelerated the digitalization trends in both the government and private sectors. As such, lack of digital readiness in terms of skill and equipment has come to fore. The dangers and risks in cyber-realm have also emerged. The new normal in fact ushered intensive use of online platforms and structures which will stay. Thus, through digital education, the City Government would be able to address the urgency in responding to the multi-sectoral call for enhanced public service delivery and improved Internet access under the new normal;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.
