A RESOLUTION GIVING RECOGNITION TO THE QUEZON CITY DISASTER RISK REDUCTION AND MANAGEMENT OFFICE (QCDRRMO) FOR THE CONCEPTUALIZATION AND IMPLEMENTATION OF ORIGINAL TRAINING COURSES ON DISASTER RISK REDUCTION MANAGEMENT.

WHEREAS, the Quezon City Disaster Risk Reduction and Management Council (QCDRRMC), through the Quezon City Disaster Risk Reduction and Management Office (QCDRRMO), addresses concerns and carries out solutions on disaster risk and preparedness, prevention and mitigation;

WHEREAS, since its creation in 2015, the QCDRRMO has conceptualized and implemented new and original training courses on disaster risk reduction management (DRRM) and DRRM-related matters to enhance the knowledge and skills of residents, thereby making Quezon City resilient to natural and man-made disasters;

WHEREAS, under the current leadership, the QCDRRMO Training Unit designed and spearheaded its very own novel and groundbreaking DRRM training courses for capacity enhancement of different sectors of the community, namely: (1) the New Normal Instructor's Development Training Course; (2) the First Responder's Training Course; and (3) the Community Survival Skills Enhancement Training;

WHEREAS, the New Normal Instructor's Development Training Course was designed by the Training Unit to develop potential disaster preparedness instructors in the barangay level to represent the QCDRRMO in the conduct of disaster preparedness seminars and trainings within their jurisdiction;

WHEREAS, the First Responder's Training Course was designed by the QCDRRMO Training Unit to enhance the capability of the Barangay Health Emergency Response Team (BHERT) and equip its members with helpful knowledge and skills in rendering services during any emergency in the barangay, such as the administration on first aid and basic life support;

WHEREAS, the Community Survival Skills Enhancement Training was designed by the QCDRRMO Training Unit specifically for the youth sector to develop their situational awareness in case of disaster, exposing them to real-life scenarios to gauge how they will react and improve their abilities.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to give, as it does hereby give, recognition to the Quezon City Disaster Risk Reduction and Management Office (QCDRRMO) for the conceptualization and implementation of original training courses on disaster risk reduction management.

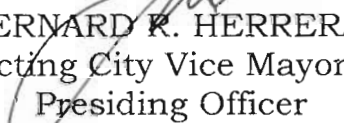
