RESOLUTION NO. SP-9171, S-2023

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT REPRESENTED BY THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER AND SIGN A MEMORANDUM OF AGREEMENT WITH THE TRINITY UNIVERSITY OF ASIA (TUA), REPRESENTED BY ITS PRESIDENT DR. GISELA D.A. LUNA, AND WITH FIVE QUEZON CITY BARANGAYS, NAMELY, BARANGAY KALUSUGAN, BARANGAY ROXAS, BARANGAY DAMAYANG LAGI, BARANGAY TATALON, AND BARANGAY STO. DOMINGO, REPRESENTED BY THEIR RESPECTIVE PUNONG BARANGAYS FOR THE IMPLEMENTATION OF COMMUNITY SERVICE INITIATIVES OF TUA, SUBJECT TO EXISTING LAWS, RULES, AND REGULATIONS.

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that local government units shall promote the general welfare and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, the Trinity University of Asia (TUA), a recognized institution by the Commission on Higher Education, envisions to be “A premier Christian University in Asia and the Pacific with a community of learners as leaders towards a humane society”, thus facilitating people’s empowerment towards social change and development;

WHEREAS, in line with this vision, TUA intends to render community service that will assist in the development initiatives of five (5) Quezon City barangays, namely Barangay Kalusugan, Barangay Roxas, Barangay Damayang Lagi, Barangay Tatalon, and Barangay Sto. Domingo;

WHEREAS, the partnership among the parties cover, among others, the implementation of community service projects, programs and services in the five (5) barangays subject to the policies, procedures, and guidelines governing the Social Services Development Department of the Local Government of Quezon City. TUA shall also assist in providing necessary services that will aid in the development initiatives of the said barangays;

WHEREAS, this partnership promotes cooperation with the academe, local government, and barangays to ensure the provision of quality services for the constituents of the City.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Quezon City Government represented by the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter and sign a Memorandum of Agreement with the Trinity University of Asia (TUA), represented by its President Dr. Gisela D.A. Luna, and with five Quezon City barangays, namely, Barangay Kalusugan, Barangay Roxas, Barangay Damayang Lagi, Barangay Tatalon, and Barangay Sto. Domingo, represented by their respective Punong Barangays for the implementation of community service initiatives of TUA, subject to existing laws, rules, and regulations.


