RESOLUTION NO. SP- **9199**, S-2023

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO GLOBE STT GDC, INC., FOR THE PROPOSED SEVEN (7)-STOREY DATA CENTER BUILDING (NORTH AND SOUTH TOWER) LOCATED AT LOTS 1, 2, 3, AND 812-NEW-B-2-A-1, REGALADO AVENUE, BARANGAY FAIRVIEW, DISTRICT V, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Globe STT GDC, Inc., is applying for the issuance of a Certificate of Exception for the Proposed Seven (7)-Storey Data Center Building (North and South Tower) located at Lots 1, 2, 3, and 812-NEW-B-2-A-1, Regalado Avenue, Barangay Fairview, District V, Quezon City;

WHEREAS, pursuant to Paragraph 2, Section 55, Article VII of Ordinance No. SP-2502, S-2016, an exception is required for the aforesaid project upon authorization from the City Council;

WHEREAS, the proposed project will not adversely affect public health, safety, and welfare, and is in keeping with the general pattern of development in the community;


NOW, THEREFORE,


