WHEREAS, under Section 17 of Local Government Code of 1991, the Local Government may exercise such powers and discharge such functions as may be necessary, appropriate or incidental to the delivery of basic services and facilities including tax information systems;

WHEREAS, to intensify its tax collection efforts which will lead to the increase of locally-sourced revenues, there is a need to improve the transportation services of the City Treasurer's Office and other offices involved in revenue collection through the use of fuel-efficient motorized vehicles;

WHEREAS, in its desire to assist the Quezon City Government to improve its tax collection, Motortrade Nationwide Corporation is willing, out of patriotism and love of country, to convey, by way donation to the Quezon City Government, the motorized vehicles hereunder described;

WHEREAS, the Deed of Donation and Acceptance is an integral part of this resolution, attached as "Annex A".
