A RESOLUTION ADOPTING THE ANNUAL FEAST OF THE NUESTRA SEÑORA DE SALVACION DE LA LOMA AS ONE OF THE CULTURAL FESTIVALS OF QUEZON CITY, RECOGNIZING ITS PARISH AND FESTIVITIES AS PART OF THE CITY'S CULTURAL HERITAGE

WHEREAS, the Quezon City Government desires to promote culture and arts by recognizing places and people that contribute to its culture and heritage;

WHEREAS, the Parish of Nuestra Señora de Salvacion de La Loma is located in the First Legislative District of Quezon City, specifically La Loma District which comprises Barangays Salvacion, Paang Bundok, N.S. Amoranto, San Isidro Labrador and San Jose;

WHEREAS, the Nuestra Señora de Salvacion de La Loma originated from an Aglipayan Church in Peñafrancia, Paco, Manila, and was relocated to La Loma in 1923 by Quintin Ong who subsequently conveyed its care to Severa Barican, Cabeza de Barangay of Paang Bundok at that time;

WHEREAS, the *Nuestra Señora de Salvacion de La Loma* was dedicated to the Catholic Church in 1930 and was moved to different locations including chapels in A. Bonifacio Avenue until 1939;

WHEREAS, in 1967, the Quezon City Government, through then Mayor Norberto Amoranto, purchased a land along Don Manuel Agregado, and a permanent chapel was established for the patron through the assistance of the *La Loma Ladies Association* of Mrs. Asisola Amonto;

WHEREAS, since 1980, the *Samahang Salvacion* and the people of *Barangay Salvacion* from District I were entrusted with the care of *Nuestra Señora de Salvacion de La Loma*;

WHEREAS, this year marks the 100th Anniversary of the *Nuestra Señora de Salvacion de La Loma*'s relocation to the *La Loma District* of Quezon City;

WHEREAS, the feast of the *Nuestra Señora de Salvacion de La Loma* is celebrated every 3rd Sunday of May and the inclusion of its parish and festivities to the City's cultural festivals will promote its significance and contribution to our culture and heritage;

WHEREAS, *Barangay Salvacion* passed a *Barangay Resolution* requesting the *Sangguniang Panlungsod* of Quezon City to pass a *Resolution* adopting the annual feast of the *Nuestra Señora de Salvacion de La Loma* as one of the cultural festivals of Quezon City.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to adopt, as it does hereby adopt, the annual feast of the *Nuestra Señora de Salvacion de La Loma* as one of the cultural festivals of Quezon City, recognizing its parish and festivities as part of the City's cultural heritage.

RESOLVED FURTHER, that the feast of *Nuestra Señora de Salvacion de La Loma* be included in the official cultural festivals of Quezon City to promote its historical significance of 100 years in our City.
