*WHEREAS, it is declared the policy of Quezon City Government to provide the necessary equipment and tools to our barangays to ensure proper and efficient delivery of services to its constituents;*

*WHEREAS, pursuant to the said policy, the Quezon City Government represented herein by the City Mayor, Honorable Ma. Josefina G. Belmonte, through the initiative of the Office of Councilor Victor "Vic" Bernardo, has procured forty-four (44) multipurpose tents with the following specifications:*

SPECIFICATIONS:

- TWENTY-TWO (22) PIECES OF 10X10 FEET MULTIPURPOSE TENTS;
- TWENTY-TWO (22) PIECES OF 8X10 FEET MULTIPURPOSE TENTS;

WHEREAS, the said multipurpose tents shall be used by QCitizens from recipient barangay/s, through the Liga ng mga Barangay, to give shade and shelter in the availment of various public services;

WHEREAS, as the primary source of funding for the said multipurpose tents, it is incumbent upon the City Government to undertake proper turnover to the intended recipient/s in order to conform with the government's auditing requirements;

WHEREAS, a Deed of Donation shall be executed for the transfer of the ownership of the 44 multipurpose tents to the recipient/s.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Deed of Donation with the Office of the Liga ng mga Barangay to donate forty-four (44) multipurpose tents and transfer the ownership thereof without cost to the recipients.

RESOLVED FURTHER, that the ownership of the said multipurpose tents be transferred to the intended recipient/s through a Deed of Donation to be signed by the City Mayor, Honorable Ma. Josefina G. Belmonte, the Office of Councilor Victor "Vic" Bernardo as the main proponent, and the Office of the Liga ng mga Barangay represented by Honorable Freddy S. Roxas, Liga President and Ex-Officio City Councilor.
