A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH DEPED DIVISION OF QUEZON CITY FOR THE ESTABLISHMENT OF JOSE RIZAL HIGH SCHOOL

WHEREAS, the Schools Division of Quezon City is in need of an additional secondary school, particularly in Barangay Holy Spirit, Quezon City, to accommodate 6,292 or more prospective enrollees;

WHEREAS, Ordinance No. SP-3035, S-2021, entitled "An Ordinance Converting the Existing Holy Spirit National High School Annex located at Republic Avenue, Barangay Holy Spirit into a Separate Independent High School," was approved by the Quezon City Council on June 25, 2021;

WHEREAS, Ordinance No. SP-3072, entitled "An Ordinance Renaming the Holy Spirit National High School Annex located at Republic Avenue, Barangay Holy Spirit, District II, Quezon City to Jose Rizal High School," was enacted and approved by the City Council on December 13, 2021;

WHEREAS, the proposed Jose Rizal High School located at St. Michael Street, Republic Avenue, Barangay Holy Spirit, District II is currently an Annex of Holy Spirit National High School. The school building was built for the proposed educational institution with water and electric supply;

WHEREAS, the establishment of the proposed Jose Rizal High School is considered an urgent need and the Quezon City Government agrees to be a counterpart of the Department of Education (DepEd) in the establishment of the proposed school;

WHEREAS, according to the DepEd Order No. 40, S.2014, a Memorandum of Agreement between the DepEd and appropriate Local Government Unit is required for the establishment of Public Secondary Schools;

WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Quezon City Government, through the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Memorandum of Agreement with DepEd Division of Quezon City for the establishment of Jose Rizal High School.

RESOLVED FURTHER, that a copy of the subject Memorandum of Agreement be made an integral part of this Resolution.


