A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO S-3 TUBE ICE CORPORATION FOR THE OPERATION OF A ONE (1)-STOREY TUBE ICE MANUFACTURING PLANT (AS BUILT) LOCATED AT LOT 2, BLOCK 82, NO. 54 MENDOZA STREET, BARANGAY PALTOK, DISTRICT I, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE OF 2016
