RESOLUTION NO. SP- 9462, S-2023

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A DEED OF DONATION AND ACCEPTANCE WITH VARIOUS BENEFICIARIES IN THE FOURTEEN (14) BARANGAYS IN DISTRICT V, QUEZON CITY, FOR THE DONATION OF TWO HUNDRED NINETEEN (219) UNITS OF TENTS AND AUTHORIZING THE TRANSFER OF OWNERSHIP TO ALL RECIPIENTS WITHOUT COST

WHEREAS, Section 455(b)(1)(vi) of Republic Act No. 7160 states that "the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance";

WHEREAS, the said tents may also be used for meetings and activities of different Homeowners' Associations in their respective barangays;

WHEREAS, the tents shall be distributed to qualified beneficiaries from Barangay Bagbag, Barangay Capri, Barangay Fairview, Barangay Gulod, Barangay Kaligayahan, Barangay Lagro, Barangay Nagkaisang Nayon, Barangay North Fairview, Barangay Nova Proper, Barangay Pasong Putik, Barangay San Agustin, Barangay San Bartolome, Barangay Sta. Lucia, Barangay Sta. Monica;

WHEREAS, the following are the specifications of the tents to be donated and distributed:

1. Tent 11 ft. x 11 ft. Tent Frame: G.I. PIPE post and trusses, galvanized tube 0.75 inch x 1.5 inches x S#20 flat bar 1.25 inches x 6mm thick coated with silver paint, collapsible, tent cover 22 ounce vinyl canvass cover with full digital color print. Combination of pink, blue and white.
2. 10 ft. x 10 ft. made of hd tarpaulin canvass 0.75mm thick with lettering of the QC logo metal frame and support made of G.I. PIPE with 1 ½ diameter and inner G.I. PIPE 1 Diameter for adjustable height metal base with trusses collapsible and easy to transport.
3. Tent 11 ft. x 11 ft., Tent Frame: G.I. Pipe post and trusses, Galvanized tube: 0.75 inch x 1.5 inches x S#20, flat bar, 1.25 inch x 6mm thick coated with silver paint, collapsible tent cover, 22 ounce Vinyl canvass cover with full digital color paint Height 8 ft. adjustable to 1 ft.
4. Tent 11 ft x 11 ft., custom made: Tent Frame GI Pipe post and trusses, Galvanized Tube: 0.75 x 1.5" x S#20 Flat Bar: 1.25 inches x 6mm thick coated with Silver paint. Collapsible Tent Cover, 22 ounce vin22-ounce with full digital color paint.

WHEREAS, the donation of two hundred nineteen (219) units of tent aims to improve the delivery of administrative services in District V, Quezon City;

WHEREAS, for the effective turn-over of the ownership of the said two hundred nineteen (219) units of tent to the recipient organizations, the City, as Donor, shall assume all fees and costs of the Donation.
