A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO SUPER-AIRE REFRIGERATION & CONTRACTORS, INC./MARVIN GO FOR THE OPERATION OF A THREE (3)-STOREY COMMERCIAL BUILDING WITH WAREHOUSE AND STAFF QUARTERS (AS BUILT) LOCATED AT LOTS 4-A-1 AND 4-A-2, ST. FRANCIS STREET, BARANGAY IMMACULATE CONCEPCION, DISTRICT IV, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016

WHEREAS, *Super-Aire Refrigeration & Contractors, Inc./Marvin Go is applying for the issuance of a Certificate of Exception for the operation of a Three (3)-Storey Commercial Building with Warehouse and Staff Quarters (As Built) located at Lots 4-A-1 and 4-A-2, St. Francis Street, Barangay Immaculate Concepcion, District IV, Quezon City;*
