WHEREAS, Quezon City Ordinance No. SP-2773, S-2018, as amended, and Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorize the Quezon City Council to grant or renew the special permit of Electronic Bingo, and to transfer its business location of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to amend, as it does hereby amend, Resolution No. SP-9303, S-2023 entitled "A Resolution renewing the Special Permit of Easy E-Bingo, Inc. to operate an Electronic Bingo Games establishment at EPS Building, No. 848 Quirino Highway, Barangay Gulod, Novaliches, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR)", by changing the business address therein to Lower Ground Floor, 1123 Novaliches Plaza Mall, Quirino Highway corner Ramirez Street, Barangay Novaliches Proper, District V, Quezon City.

RESOLVED FURTHER, that this Resolution shall not renew nor extend the validity of Easy E-Bingo, Inc.'s previous Special Permit.
