A RESOLUTION GRANTING A SPECIAL PERMIT TO GOLDSMITH GAMING CORPORATION TO OPERATE ELECTRONIC GAMES (E-GAMES) LOCATED AT UNITS A & B GROUND FLOOR, TOLEDO BUILDING, NO. 277 TOMAS MORATO AVENUE CORNER SCOUT LIMBAGA STREET, BARANGAY LAGING HANDA, DISTRICT IV, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR)

WHEREAS, Goldsmith Gaming Corporation is a domestic corporation duly organized and existing under and by virtue of Philippine laws, located at Unit A & B Ground Floor, Toledo Building, No. 277 Tomas Morato Avenue corner Scout Limbaga Street, Barangay Laging Handa, District IV, Quezon City;

WHEREAS, the applicant was previously granted a Special Permit by the Quezon City Council for the operation of an Electronic Bingo establishment through Resolution No. SP-8821, S-2021, and now is applying to operate additional gaming activities at its existing business;

WHEREAS, the operation of Electronic Games (E-Games) is regulated and licensed by the Philippine Amusement and Gaming Corporation (PAGCOR);

WHEREAS, Quezon City Ordinance No. SP-2773, S-2018, as amended, and Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorize the City Council to grant or renew a Special Permit to business activities of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, a Special Permit to Goldsmith Gaming Corporation to operate Electronic Games (E-Games) located at Units A & B Ground Floor, Toledo Building, No. 277 Tomas Morato Avenue corner Scout Limbaga Street, Barangay Laging Handa, District IV, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate Electronic Games (E-Games) granted herein shall be subject to the following conditions, to wit:

1. The holding of E-Games shall be in accordance with the rules and regulations promulgated by PAGCOR;
2. The operation of E-Games shall not include playing of games not related to or other than E-Games;
3. The operation is enjoined to prohibit from playing the abovementioned games in their gaming site individuals below 21 years of age or students of any school, college or university;
4. Goldsmith Gaming Corporation shall remit a license fee of 3% of the gross receipt of herein grantee, which shall be made payable yearly to the City Treasurer's Office during the lifetime this Resolution, in accordance with Section 25 of Ordinance No. SP-2773, S-2018, as amended;
5. This Resolution is non-assignable, non-transferrable and site-address specific; and
6. The establishment shall not be a nuisance to public safety and order.

RESOLVED FINALLY, that this grant of a Special Permit to operate Electronic Games (E-Games) shall be valid for a period of 2 years from the approval of this Resolution and may be renewed by the City Council.


